I further agree not to sue, asset, or otherwise maintain any claim against **The Great Skate**, its officers and employees, and all other persons or entities, for bodily injury, or death, to myself or to my child arising from or connected with my/his/her participation at the great skate from any claim asserted against any of us by spectators or other third parties.
